ORDER:

In the letter first and third read above, the Government of India have conveyed the sanction of the President of India to the release of Rs.865.60 lakh for procurement of kitchen devices at primary and upper primary stage under National Programms of Mid Day Meals in Schools (MDM scheme) for 2012-2013, at the rate of Rs.5,000/- per school / centre as detailed below:-

2. Accordingly, the Director of Social Welfare has sent the proposal for sanction of funds for replacement of cooking equipments / kitchen devices in 17312 schools under National Programme of Mid Day Meals in Schools (MDM Scheme) at the rate of Rs.5000/- per school / per Noon Meal centre at a total cost of Rs.865.60 lakh indicating the name of districts, allotment of funds and number of Nutritious Meal Centres for which cooking equipment / kitchen devices have to be provided / replaced for the financial year 2012-2013, both for the primary and the upper primary stages.

3. After careful consideration of the proposal of the Director of Social Welfare, the Government accord sanction to the Director of Social Welfare to incur the expenditure to the tune of Rs. 865.60 lakh (Rupees eight crores sixty five lakh and sixty thousand only) towards procurement of kitchen devices in 17312 School Noon Meal Centres in 32 Districts at Rs.5,000/- per school under the National Programme of Mid Day Meals in Schools as detailed below:-

Subject to the conditions that expenditure relating to the procurement of பெரிய வாணலி and கரண்டி needed for the above centres for the revised variety Rice Menu including the new menu introduced in the 3219 Noon Meal Centres in 32 Pilot Blocks to

the tune of Rs.39,91,560/- shall also be met out of the Central Assistance of Rs.865.60 lakh provided for kitchen devices.

4. The expenditure sanctioned in para 3 above shall be debited to the following head of account:-

" 2236 - Nutrition-02 - Distribution of nutritious food and beverages - 102 Mid Day Meals - Schemes in the Twelfth Five Year Plan - III Centrally Sponsored schemes - SA - National Programme of Nutritional Support to Primary Education (Mid Day Meal Scheme) - 24 Materials and Supplies " (DPC 2236 02 102 SA 2406)

- 5. The expenditure sanctioned in para 3 above will be provided in R.E/F.M.A. 2013-2014. Pending provision of funds in R.E./ F.M.A. 2013-2014, the Director of Social Welfare is authorized to incur the above expenditure. However this item of expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimate 2013-2014. The Director of Social Welfare is requested to include the above expenditure in R.E/F.M.A.2013-2014 while sending the proposal to Finance (SW) Department without fail and he is also requested to send necessary draft explanatory notes to Finance Department to include the above expenditure in Supplementary Estimates 2013-2014 at the appropriate time.
- 6. The Director of Social Welfare is requested to implement the programme in the districts with the allocation of funds following the guidelines of National Programme of Nutritional Support to Primary Education 2006 as stipulated in para 2.3 (vi). The District Collectors concerned, are permitted to purchase cooking equipments / kitchen devices (stove) containers for storage of food grains and other ingredients and utensils for cooking and serving on the basis of the actual requirements of the schools. As far as possible procurement of cooking equipments & kitchen devices shall be done in a decentralized manner preferably at school / block level, so that there is no delay in making available the required devices to the schools as instructed by the Government of India.
- 7. The Director of Social Welfare and District Collectors shall maintain a separate and proper account of the money received. A register of Assets acquired out of this release shall be maintained as per rules in force. The Director of Social Welfare shall furnish the utilization certificate to Government indicating the number of schools in district once where kitchen equipments / devices have been provided through the Central Assistance received in this order and as well as quarterly progress reports periodically.
- 8. The Director of Social Welfare is requested to issue necessary instructions to Personal Assistants (NMP) to District Collectors to implement the scheme, without any deviation and also to
 - ensure better monitoring and implementation of the scheme;
 - b. ensure that the kitchen devices / utensils are uniform in type and design, according to the strength;
